The RSUs will vest on the earliest to occur of: (i) the date of the Issuer's 2025 annual meeting of stockholders if the Reporting Person is not continuing on the Issuer's board of directors or (ii) July 1, 2025. Settlement of all or a portion of the vested RSUs may be deferred by the Reporting Person, in which case, settlement will occur pursuant to the terms of the Reporting Person's applicable deferral election.
